Explanation:

The Ministry of Finance notified the amendment to Foreign Exchange Management (Non-Debt Instruments Rules) Rules 2019 to operationalise the new foreign direct investment (FDI) limits for satellite-related activities.

i. The new rules will be known as Foreign Exchange Management (Non-Debt Instruments) (3rd Amendment) Rules, 2024. The new rules will come into effect from 16th April, 2024.

iii. Under the amended FDI Policy, 100% FDI is allowed in the space sector.

- For manufacturing of components and systems or sub-systems for satellites, ground segment and user segment, up to **100% FDI** is allowed under the **automatic route**.
- For Satellites-Manufacturing and Operations; Satellite Data Products; and Ground Segment and User Segment up to 74% FDI is allowed under automatic route and FDI over 74% will require government approval.

2. As of April 2024, the Central Board of Direct Taxes (CBDT) set a record by signing _____ Advance Pricing Agreements (APAs) with Indian taxpayers in the Financial Year 2023-24 (FY24).

In Financial Year 2023-24 (**FY24**), the Central Board of Direct Taxes (CBDT) set a record by signing **125** Advance Pricing Agreements (APAs) with Indian taxpayers, comprising **86 Unilateral APAs** (UAPAs) and **39 Bilateral APAs** (BAPAs).

i. This marks a 31% increase from 95 APAs in FY23 and the highest number of APAs signed in any financial year since its inception, bringing the total to 641 comprising 506 UAPAs and 135 BAPAs.

- FY24 also saw the highest number of BAPAs signed to date, a result of Mutual Agreements with seven of India's treaty partners viz. Australia, Canada, Denmark, Japan, Singapore, the United Kingdom (UK) and the United States (US).

3. In April 2024, the government set up a seven-member panel to promote the commercially viable extraction of critical minerals found in limited quantities.



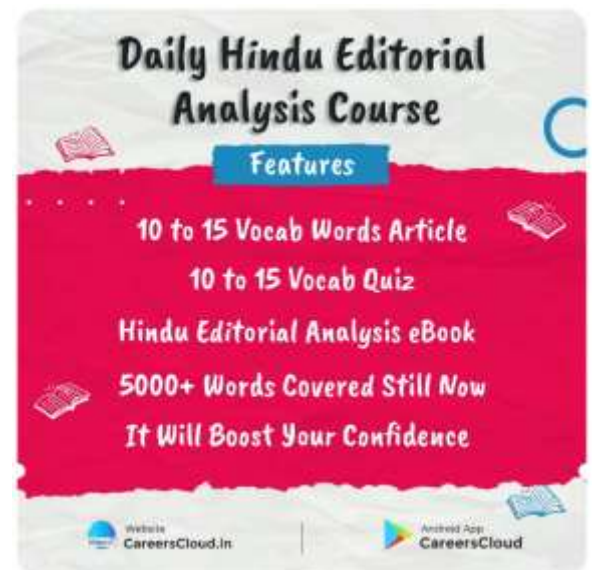
